

## Order of the Regulator No. 2021/E81

### APPROVAL OF ENERGY CHARGE ADJUSTMENT

Pursuant to section 20 of the Electricity Act 2010 ('Act'), the Electric Power Corporation has sought approval from the Regulator to implement retail rates charged to electricity consumers for the provision of electricity services.

The Order sets out the approved changes in tariffs.

### Order approving change in tariff per unit of electricity

#### 1. Induction Meter Consumers

The Electric Power Corporation is permitted to charge the following tariffs –

*For domestic induction consumers:*

Customer Usage	Usage Charge	Debt Charge	Energy Charge	Total
All	0.26	0.07	0.46	<b>0.79</b>

The Electric Power Corporation is permitted to charge the following tariffs

*For non-domestic induction meter consumers*

#### 2. Cash Power Consumers

The Electric Power Corporation is permitted to charge the following tariffs -

*For domestic cash power consumers:*

- b) the making of a new Order by the Regulator with respect to the tariffs, rates or charges for the provision of electricity services by the Electric Power Corporation.


### **Ongoing monitoring of electricity tariffs**
