



ORDER OF THE REGULATOR NO. 2026/T01
APPROVAL OF Samoa Submarine Cable Company (SSCC)
Reference Interconnection Offer (RIO)

Legislation

The Telecommunication Act 2005 ("the Act") sets forth the obligation of the dominant service provider in the Telecommunication markets in Samoa.

Section 32 (g) states that the Regulator ensures that dominant service providers in a telecommunication market for interconnection publish a reference interconnection offer in accordance with Section 37 of the Act and any regulations, rules, and orders applicable to interconnections;

Section 37 (1) (a) states that every dominant service provider designated in accordance with Section 34 shall prepare a reference interconnection offer for approval by the Regulator within the time period specified by order of the Regulator;

Regulator Decision

The Regulator, having considered the revised reference interconnect offer 2026 (RIO 2026) of the Samoa Submarine Cable Company (SSCC) for wholesale international Internet bandwidth capacity, hereby **approves** the RIO 2026.

In compliance with section 8(1)(r) of the Telecommunications Act 2005 (the Act), the Regulator revoked the Order of the Regulator No.2024/T05 and replaced it with the Order of the Regulator No.2026/T01

The RIO 2026 outlines the terms and conditions under which SSCC will interconnect with other licensed service providers in accordance with the Telecommunication Act of 2005.

The Regulator has considered the following factors in approving the RIO 2026:

- a. The RIO 2026 is fair, reasonable, and non-discriminatory.
- b. The RIO 2026 is in the public interest.
- c. The RIO 2026 will promote competition in the telecommunications market in Samoa.

The Regulator is positive that the RIO 2026 would satisfy market demands for telecommunications in Samoa and benefit both customers and the country as a whole. Other authorized telecommunications operators will be able to access submarine cable capacity through the RIO 2026 at a fair and acceptable price. This will result in consumers paying less for Internet access, and the quality of the Internet service in Samoa will improve.

Order

- (i)SSCC to publish the RIO on their website;
- (ii) Send a copy to any service provider upon request.

Duration of the Order:

The Order will expire on the earlier of

- 1) The Regulator revoking this Order; or

- 2) The making of a new Order by the Regulator for the next revised RIO until the Regulator sees fit for another review.

The RIO 2026 will be effective from **22 January 2026**
