ORDER OF THE REGULATOR NO. 2019/T66

APPROVAL OF RETAIL TARIFFS FOR SERVICES PROVIDED BY DIGICEL SAMOA LIMITED

WHEREAS:

On the 12th April 2019, the Office of the Regulator received a new tariff application from Digicel Samoa Ltd ("Digicel") for its **All in One Bundles** for the Regulator's review and approval.

As a result, the Regulator has seen it fit to amend the Schedule of tariffs specified under Schedule 1, Part 1.3(1.3.1 & 1.3.2) Prepaid All in One Bundles in the Order of the Regulator No. 2018/T52 in endorsement of the tariffs and charges specified in the schedules to this Order.
