ORDER OF THE REGULATOR No.2020/T02

AMENDMENT OF ORDERS OF THE REGULATOR No. 2019/T80 & No. 2019/T82

Pursuant to section 8 (1) (r) of the *Telecommunications Act 2005* the Regulator makes this Order to amend Orders of the Regulator No.2019/T80 and No.2019/T82:

(1) Order of the Regulator No. 2019/T80 (Digicel Samoa Limited)

i. is amended by removing the following paragraphs:

"The tariffs specified in Schedules to this Order shall be the tariffs specified for the purpose of this Order for the period of 12 months.

Any new tariff application shall be assessed together during review of tariffs specified in Schedules to this Order on the **08**th **September 2020**, of which Digicel is to submit request for the Regulator's approval.

A no submission of request for review of tariffs specified in this Order will be interpreted as the same tariffs proceeding for the next 12 months round."

- ii. The following provisions are inserted preceding the VAGST provision:
 - a. All tariffs submitted for approval of the Regulator must be filed at least one
 (1) week before intended launch date.
 - b. All approved tariffs will be revisited annually by the Office of the Regulator in the month of October.

(2) Order of the Regulator No. 2019/T82 (Bluesky Samoa Limited)

i. is amended by removing the following paragraphs:

"The tariffs specified in Schedules to this Order shall be the tariffs specified for the purpose of this Order for the period of 12 months.

Any new tariff application shall be assessed together during review of tariffs specified in Schedules to this Order on the 08th October 2020, of which Bluesky is to submit request for the Regulator's approval.

A no submission of request for review of tariffs specified in this Order will be interpreted as the same tariffs proceeding for the next 12 months round."

- ii. The following provisions are inserted preceding the VAGST provision:
 - a. All tariffs submitted for approval of the Regulator must be filed at least one
 (1) week before intended launch date.

- b. All approved tariffs will be revisited annually by the Office of the Regulator in the month of October.
- (3) General Provision for Amended Orders of the Regulator No. 2019/T80 and 2019/T82
 - i. Excluding the former provisions (that have been amended), all other provisions of Orders No. 2019/T80 and 2019/T82 shall remain in full force and effect.
 - ii. These amendments shall apply from the Date of this Order of the Regulator No. 2020/T02.
